

**Philip Barbour High School Chapter
National Honor Society
Chapter Bylaws**

SELECTION FOR MEMBERSHIP:

The Philip Barbour High School Chapter of the National Honor Society is an organization designed to create enthusiasm for scholarship, stimulate a desire to render service, promote leadership, and develop character in students of the high school. The selection of students for membership in the National Honor Society is based upon the following procedures, which are in accordance with the National Honor Society Constitution and the National Honor Society Handbook.

1. The selection procedure should be determined by the faculty council and must be published. The procedure is subject to review and revision by the faculty council on an annual basis.
2. Junior and senior students' academic records will be reviewed through the most recently completed semester to determine which students meet the eligibility requirement which is a minimum cumulative scholastic average of at least 3.5
3. The principal or delegated National Honor Society advisor(s) will form an anonymous faculty council consisting of five professional staff from various subjects/disciplines who will review all National Honor Society Student Applications and other verifiable information in order to select the candidates who will be awarded membership to the Philip Barbour High School Chapter of the National Honor Society and recognized at the next induction ceremony. In cases which the principal delegates the faculty council formation to the National Honor Society advisor(s), the principal may request a list of the faculty council members if valid and appropriate justification is provided. The National Honor Society advisor(s) will attend the selection process meeting but are not counted as one of the five faculty council members. The faculty council may not include administrators and support staff (e.g. custodians, secretaries, etc.). The National Honor Society advisor(s) may not cast a vote for any candidate. A faculty council member cannot cast a vote for any candidate who is a member of their immediate family.
4. All students who are eligible scholastically will be notified and told that for further consideration for selection to the National Honor Society Chapter, they must fully complete the National Honor Society Student Application and submit it by the given deadline. All eligible students will be given due process by the faculty council.
5. All Philip Barbour High School Complex faculty members are invited to make written comments about and rate candidates in regards to character, service, and leadership. These comments and ratings can be used as part of the consideration for a candidate's eligibility and qualifications but may not be counted as votes in the selection process. However, the five appointed members of the faculty council must make the actual selections. It is not permissible to take an entire faculty vote.

6. The National Honor Society Application will be reviewed by the faculty council along with any other verifiable information about each candidate from their high school career thus far (e.g. faculty evaluation forms and attendance and discipline records). The faculty council has the freedom and authority to interview candidates personally. Candidates receiving a majority vote from the faculty council will be inducted into the chapter.
7. Once inducted into the chapter, a student continues to be a member until graduation unless dismissed as determined by the National Honor Society Constitution and/or the Philip Barbour High School Chapter National Honor Society Code of Conduct, which students sign and agree to prior to their induction. A member can be considered for dismissal when performance falls below the acceptable levels of any of the standards by which the student was selected.
8. Students who transfer into Philip Barbour High School as National Honor Society members from another Chapter are accepted into the Philip Barbour High School Chapter if all membership requirements of this Chapter are met.
9. The faculty council may request to reconvene to discuss and act upon National Honor Society selections, membership, or other matters by presenting to the principal such a request in writing, signed by the majority of the council.
10. Questions regarding the National Honor Society, its functions, or the selection process may be directed to the principal, associate principal or National Honor Society advisor(s). The National Honor Society handbook is available for review from either the advisor(s) or the administration. The following guidelines are offered to assist in the definition of criteria in the area of scholarship, leadership, service, and character.

Scholarship: The student of scholarship must have a cumulative scholastic average of at least 3.5 through the most recently completed semester. This average is considered as the standard of excellence.

Leadership: The student who exercised leadership:

- Is resourceful in proposing new problems, applying principles, and making suggestions;
- Demonstrates leadership in promoting school activities;
- Exercises influence on peers in upholding school ideas;
- Contributes ideas that improved the civic life of the school;
- Is able to delegate responsibilities;
- Exemplifies positive attitudes;
- Inspires positive behavior in others;
- Demonstrates academic initiative;
- Successfully holds school offices or positions of responsibility, conducting business efficiently and effectively and without prodding, demonstrates reliability and dependability;
- Demonstrates leadership in the classroom, at work, and in school or community activities;
- Is thoroughly dependable in any responsibility accepted.

Service: The student who serves:

- Is willing to uphold scholarship and maintain a loyal school attitude;
- Participates in some outside activity: for example, Girl Scouts, Boys Scouts, Church groups, volunteer services for ages, poor or disadvantaged; family duties;
- Volunteers dependable and well-organized assistance, is gladly available, and is willing to sacrifice to offer assistance
- Works well with others and is willing to take on difficult or inconspicuous responsibilities;
- Cheerfully and enthusiastically renders any requested service to the school;
- Is willing to represent the class or school in inter-class and inter-scholastic competition;
- Shows courtesy by assisting visitors, teachers and students.

Character: The student of character:

- Takes criticism willingly and accepts recommendations graciously;
- Consistently exemplifies desirable qualities of behavior (cheerfulness, friendliness, poise, stability);
- Upholds principles of morality and ethics;
- Cooperates by complying with school regulations concerning property, programs, office, halls, etc.;
- Demonstrates the highest standards of honesty and reliability;
- Shows courtesy, concern, and respect for others;
- Observes instructions and rules, punctuality, and faithfulness both inside and outside of the classroom;
- Has powers of concentration and sustained attention as shown by perseverance and application to studies;
- Manifest truthfulness in acknowledging obedience to rules, avoiding cheating in written work, and showing unwillingness to profit by the mistakes of others; Actively helps to ride the school of bad influences or environment.

NATIONAL HONOR SOCIETY OFFICERS:

The officers and duties of the officers of the Philip Barbour High School Chapter of the National Honor Society may include:

- President: preside at all meetings, appoint committees, prepare (with the assistance of advisors and other officers) an agenda for all meetings, and organize and assist with all club projects.
- Vice President: preside at any meeting when the President is absent, serve as chairman of the program committee which is responsible for providing any progress for meetings, and assist with all club projects.
- Secretary: record and report the minutes of all regular, special, and committee meetings (committee chairmen should provide minutes to secretary for committee meetings), keep the official Chapter membership signature book, and assist with all club projects.
- Reporter: submit all publicity for Chapter activities in a timely fashion to the local newspapers, school newspapers/publications, or yearbook in addition to assisting with the advertisement of club projects and activities.

- Historian: keep a scrapbook, including narrative, to show the Chapter's and members' activities through pictures, newspaper clippings, and other memorabilia.

PLEDGE:

I pledge myself to uphold the high purposes of the National Honor Society to which I have been selected;

I will be true to the principles for which it stands;

I will be loyal to my school;

and I will strive to excel and encourage high standards of scholarship, service, leadership, and character.

DUES AND OTHER EXPENSES:

The Chapter membership dues may be paid annually on behalf of the students by the National Honor Society Chapter or paid for by the members as decided by the Chapter advisor(s). Membership pins, stoles, and other memorabilia are not required for membership or graduation and will be ordered at the expense of the members. All students are responsible for maintaining and submitting fundraiser and club project/activity money by announced deadlines; diplomas may be withheld if outstanding dues are not met.
